Subject: 15th R. M. Halwai Memorial District Shooting Competition Rifle / Pistol event at BARODA RIFLE CLUB, Govindrao Sawant Outdoor Sports Complex, Near Darbar Chokadi, Manjalpur, Vadodara-390 011 from 28/08/2021 to 29/08/2021.

Dear Sir,

It has been decided to hold **15th R. M. Halwai Memorial District Shooting Competition Rifle / Pistol event** from 28nd to 29rd August 2021 at Baroda Rifle Club, Govindrao Sawant Outdoor Sports Complex, Near Darbar Chokadi, Manjalpur, Vadodara – 390 011. Those competitors who want to participate in these Competitions are requested to go through the following instructions carefully, for their own convenience and to ensure smooth and successful conduct of the **15th R. M. Halwai Memorial District Shooting Competition Rifle / Pistol event**.

All the matches will be conducted according to I.S.S.F. rules and N.R.A.I Match Book-2016 rules.

- (1) The entry will be accepted through respective District/Unit. The entrees with normal fee will be accepted till 8:00 pm on 24/08/2021. Late entry with triple entry fee will be accepted till 8:00 pm on 26/08/2021. The entry form should be sent to **The Rifle Shooting Association of Vadodara C/o Baroda Rifle Club, Govindrao Sawant Outdoor Sports Complex, Near Darbar Chokadi, Manjalpur, Vadodara – 390 011**. Name of the competitor must be written on the back side of the photographs declaration form must be filled and completed along with entry form without the declaration form and incomplete entry form will be rejected.
- (2) Shooters, who are below 21 years , 19 years and 16 years of age as on 31st December 2021, will be considered under the category of junior (2001 onwards), Youth (2003 onwards) and Sub Youth (2006 onwards) respectively for the 15th R.M.H.M.D.S.C. **15th R.M.H.M.D.S.C. All competitors entering for junior/Youth event must attach an attested copy of a certificate of their proof with their form incomplete applications are liable for rejection.**
NOTE: Sub Youth age 12 to 16, Youth age 17 to 18, junior age 18 to 21 & Senior above 21 year.
- (3) Shooter who participate and qualify as per N.R.A.I. rules and standards shall be entitled to receive medals.
- (4) Shooter furnishing incorrect information shall be debarred from taking part in this championship for two years. All are requested to go through the instruction carefully and ensure strict Compliances.
- (5) All participants are expected to abide by the rules and regulations for the 15th R.M.H.M.D.S.C. Discipline on and off the field is very essential.
- (6) Change in matches is not allowed once the entry is submitted.




- (8) The organizer will have right to close any match or event in case of emergency or otherwise without assigning any reason for such an action on their part.
- (9) Shooting Kit (Clothing and Equipment) of the competitor during the competition will be strictly according to I.S.S.F. standard for all matches.
- (10) All competitors of the affiliated District Rifle Association / Club / Unit should get their scores achieved in the last any competition District / State / Pre-National / National certified by the respective nominees.
- (11) In case of a new shooter who has not participated in any such shooting Competition organized by District Association / S.G.F.I. / A.I.U. / G.S.R.A. / N.R.A.I. the club of which he is a member, such club will have to certify the scores achieved in various events in which the shooter desire to participate. (Limited to this championship.)
- (12) It is made clear by this circular that R.S.A.V will not give/ issue any Air Weapon/ Pellets during the competition.
- (13) Shooter who is taking part in peep sight rifle matches is not allowed to take part in open sight Rifle matches or Vice Versa and shooter who is taking part in Pistol matches is not allowed to take part in Rifle matches or Vice Versa.
- (14) Youth can also take part in senior and junior category. However junior can take part in the corresponding senior category also.
- (15) In I.S.S.F and N.R. matches, only Three (3) shooters will be allowed to use common weapon. The names of shooters likely to use common weapon should be intimated together with the weapon number to the Organizing Secretary in advance to enable to work out the details for the conduct of the relevant matches.
- (16) The programme of competition is tentative and subject to change. The Organizers have the right to change/ modify the programme according to the prevailing conditions during the competition. The programme of the competition is attached here with.
- (17) All shooters and team officials must be familiar with the programme. (Enclosed here with).
- (18) All scoring **protest must be submitted within 30 minutes** after the official scores are posted on the score board with the protest fee Rs.300/-.
- (19) Details of the matches will be posted on the notice board. Participants/ Club/ District association are requested to check their event starts.
- (20) Those shooters who are taking part in the 15th R.M.H.M.D.S.C. they must have to fill up in the from their residence addresses Native place/ Club / Association will be rejected but there is no affiliated Club / Association in their territory this rules is exempted for particular shooter.
- (21) It is responsibility of the competitors, District Rifle Association / Club to be completely familiar, understand the competition rules of I.S.S.F. and N.R.A.I. and it is so presumed when they sign the competition entry form and shall agree to abide by the said rules.
- (22) Safety Flag is compulsory in Rifle / Pistol during Competition.
- (23) The Shooters / Officials may contact the Organizing Secretary, 15th R.M.H.M.D.S.C. For any further information / Details that may be required by them and might have not been covered by the above instructions at the following Address :-
